PLEASE NOTE

1. IMMEDIATE USE OF CEMETERY PLOT

Our charge for all the above items is valid for a period of thirteen (13) months from the date of burial. To avoid additional charges, please ensure that this form reaches our office within the prescribed period.

2. FUTURE USE OF RESERVED GROUND

For reserved ground refer to a 'future schedule of costs' which will reflect the prevailing costs associated with items (c) and (d) above. If burial occurs more than twelve (12) months after purchase (and the monument is erected within the following thirteen (13) months), then JCT will invoice for the cost increase for items (c) and (d) above.

3. PROCEDURE FOR THE ERECTION OF A MONUMENT

Please complete the declaration and the inscription details on the form, page 4, within twelve (12) months from the date of burial. The text for the monument in English and Hebrew must be endorsed by a Minister of the Jewish religion, prior to forwarding to the JCT office.

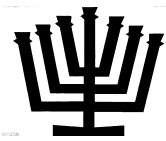


